Prior to the 2021 Annual Report, the college reported using internal MIS data. Since 2022, the Research Office has used Chancellor's Office's preliminary Student Success Metrics (SSM) to complete the ACCJC Annual Report. The use of SSM may result in lower counts/percentatges for some Institutional-Set Standards.

As of 2023, students who completed an Associate Degree for Transfer (ADT) will be included in the actual number of associate degrees (i.e., question 14c). More specifically, the 637 students who "Earned an Associate Degree Not for Transfer"(according to SSM 607) in 2021-2022 will be replaced by the count of students who "Earned Any Associates Degree" (SSM 631), which is 833. If the same metric had been used in prior years the list for years 2019-2020 and 2020-2021 would have been 771 and 895, respectively.
