 2. The TimelyMD will provide access to 24/7 counseling/no-cost virtual visits, student-focused physicians and counselors, basic needs resources and services, etc.
 - a. Triage mental health support on a variety of issues from relationship issues to anxiety/emotional support. Access to licensed counselors in your state with flexible scheduling
 - b. Allows for the monthly calendar for TimelyCare sessions
