patch sample and replace with a circle), uniforms (traditional vs. polo shirts), vehicle logo. 70% of departments use stars. Proposing a department of safety shield. Consulted with students, who thought a star is "too police-y." Shield says "Department of Public Safety."

c) DPS timeline before the department can become operational – Brian Travis Dec 1-10 interviews for new Chief of Department of Public Safety; could be on Jan 19 Board agenda (tight timeline). Questions about who is on the interview panel. New chief will undergo psychological and background check. Will likely extend month-to-month contract until department gets set up. After the presentation, VP Williams motioned to accept the recommendations of Lt. Travis for badges, patches, uniforms, and vehicles. 2<sup>nd</sup> by Myron Hord. Motion passed.




