(b) Academic Senate

Josh Scott, AS President, gave the following report:

We will be holding a tenure tea in the Boardroom on October 11th, 4-6pm. This will be a chance to not only celebrate our newly tenured faculty, but also our faculty who achieved tenure during the pandemic. We will also be celebrating our distinguished faculty and Joe Conrad, faculty emeritus.

The SEA plan is going well with broad campus input. I appreciate the inclusive leadership of VP Neeley.

We have been exploring hyflex, and hybrid instruction. Some colleagues are very interested in this, so we have convened a taskforce to explore issues related to pedagogy and technology. We also need to assess community (student and faculty) interest.

We are exploring how to take advantage of funds related to Zero Textbook Costs, so that we can provide stipends and other support to faculty (and departments and degree pathways) which can be designated ZTC.

(c) College Governance Council

Superintendent-President Esposito-Noy gave the following report:

- At our last CGC meeting on Sept 14th, we provided updates on Facilities projects including the landscaping project we are currently referring to as "Central Bark." Our landscape architect will be sending a survey to all employees and students asking for input on how best to landscape the former Building 100 space so as to invite engagement. In the meantime, we plan to install solar paneled seating along the walk way.
- We also discussed IT Security efforts as required by our audit firm and federal financial aid and the District's commitment to helping employees identify and report phishing emails.
- VP Wheet provided an update on the proposed budget the Board will be voting on this evening.

• VP Neeley shared updates regarding the **National Assessment of Collegiate Campus Climates** (**NACCC**) student survey which will be sent to all currently enrolled students next week, updates on our Student Equity and Achievement Plan, and the LGBTQ+ grant that she and several others submitted recently.

- We have lots of events coming up in October including book readings, Find the Falcon events, and the Fairfield Pro Tennis Challenger event.
- The campus looks beautiful and we are ready to welcome visitors to campus for these events.

I want to thank Fairfield-Suisun Unified's food service manager for working with us to provide our employees and students with breakfast and lunch service for the past two semesters.

- In late October we will have IBA training for 48 employees including managers and bargaining unit leaders. This is part of our ongoing commitment to utilize an interest-based approach in all we do.
