# (b) <u>Academic Senate</u>

Joshua Scott gave the following report:

We have hired a new coordinator for Zero Textbook Cost, Atticus Frey. We have also hired a new Center for Academic Excellence coordinator—Curly Wikkeling Miller.

This semester we plan a Joint student/faculty mixer and will also meet in Vacaville on February 13th and in Vallejo on March 27.<sup>th</sup>

Finally, we passed a resolution in support of adjunct faculty and voted to have the Senate President read it to the board. The resolution is as follows:

## **Resolution 11.21.2022:**

To Encourage Parity in Adjunct Support Within Solano Community College District

**WHEREAS**, Solano Community College adjunct faculty have served our college in crucial functions as coordinators, members of accreditation teams, guided pathways teams, and every subcommittee of the Academic Senate for many years;

**WHEREAS**, Solano Community College adjunct faculty make significant contributions to the college community even beyond the classroom, library and student services, advising students and performing other services, including mentoring other faculty and building a strong Solano community both on campus and off, often without compensation or the support provided to their full-time colleagues;

**WHEREAS**, a substantial number of Solano Community College's adjunct faculty have shown remarkable commitment to the college, serving for five, ten, even twenty years or more;

**WHEREAS,** some of our adjunct faculty belong to, live in, and participate in Solano County communities, fostering important, close and many historical legacy connections between our institution and various diverse communities throughout our county;

WHEREAS, our adjunct faculty often have extensive experience, knowledge and unique yet relevant skills both inside and outside of higher education, bringing to the table a range of perspectives from local to national leadership, experience in the fields students are currently, or plan to be working and experience with different structures and governance including self-employment, family employment and life experience that is relatable to the student's experience;

**WHEREAS**, adjunct faculty have a positive and significant impact on our students, teaching a majority of the course offerings on campus over almost all areas and departments, sometimes as the only teacher of specific courses or programs.

**THEREFORE, BE IT RESOLVED** that Solano Community College Academic Senate works with administration and adjunct coalition to develop meaningful support, including mentoring for our adjunct colleagues (newly hired and existing);

**BE IT FURTHER RESOLVED** that full-time faculty cultivate an environment in departments where adjunct faculty are included in conversations, email threads, and gatherings and given opportunities to participate in department-specific conversations and decisions.

## (d) Superintendent-President

Dr. Esposito-Noy provided the following report:

We have seen a positive mood on campus since last week and people seem pleased to be here. Our convocation keynote speaker, Dr. Emiliana Simon-Thomas from the Greater Good Science Center presented, Finding Happiness at Work: Science backed Insights and Tips" and facilitated a focused afternoon session as well. Dr. Brian Bedford also introduced his work on Diversity, Equity, Inclusion, and Belonging and how to move from talking about DEIB to implementing strategies in bite size pieces.

Enrollment, both headcount and FTES are looking better this year compared to last year at this time.

Headcount is: 8,384 compared to 8,048 this time last year.

FTES is: 2,803 compared to 2, 641 this time last year.

I want to acknowledge Dean Neil Glines for coordinating and all of the managers who participated in this week's "Deans and Donuts" at all three campuses. We had welcome tables with free donuts, coffee, and information.

Many thanks to Dean Alysa Borelli and IT for their work to clear the fraudulent applications that have continued to plague the CCC system. The task takes hours and is done manually and is essential to ensuring that only actual students remain enrolled and are eligible for federal financial aid.

Over the winter break, Cal OSHA COVID protocols for employees changed and we are required to track employees who have tested positive. Many thanks to HR Director Sal Abbate and Alison Aubert who will be assisting us with the tracking and notification protocols for the next two years.
